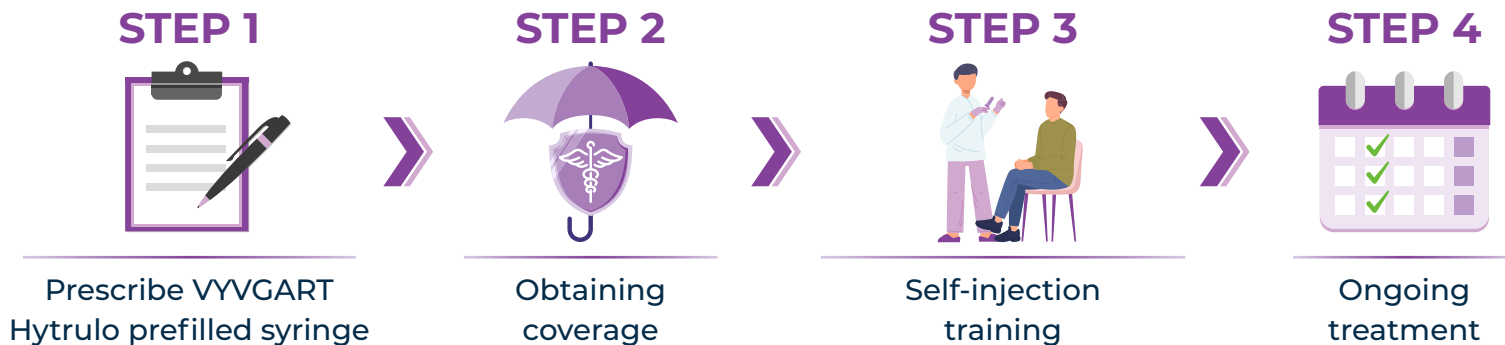

This resource is designed to help you and your office staff understand what to expect during the VYVGART Hytrulo® prefilled syringe (200 mg/mL efgartigimod alfa and 2,000 U/mL hyaluronidase) subcutaneous self-injection treatment journey.



## STEP 1

### Prescribe VYVGART Hytrulo prefilled syringe



#### Enroll Patient in My VYVGART Path

My VYVGART Path provides personalized support for enrolled patients, including triaging a new prescription for VYVGART Hytrulo prefilled syringe to an in-network specialty pharmacy. The My VYVGART Path support team helps patients understand available financial aid programs, navigate coverage details, address treatment obstacles, respond to questions, and support patients throughout their treatment process.



#### What you should do

Two ways to enroll your patients in My VYVGART Path:

- Fill out and submit the My VYVGART Path enrollment form online by clicking the "Enroll" button on [MyPathEnroll.com](https://www.mypathenroll.com) (bottom left corner).
- Download the enrollment form and fax the completed document to 1-833-698-7284

*Note: Both patient and healthcare provider (HCP) signatures are required to complete enrollment.*



#### Who will contact your patient

A My VYVGART Path representative will contact your patient to provide:

- VYVGART Hytrulo prefilled syringe treatment information
- Educational resources
- A designated Nurse Case Manager for personalized support

#### What you should do

Send your patient's VYVGART Hytrulo prefilled syringe prescription directly to the specialty pharmacy

## STEP 2

### Obtaining coverage



#### What you should know

##### My VYVGART Path:

- Can conduct a benefits investigation and send prior authorization (PA) criteria to your office
- Can route the prescription to a contracted in-network specialty pharmacy

##### Specialty pharmacy:

- Can submit the PA on your behalf

HCP offices can submit a PA through CoverMyMeds

#### Who will contact your patient

A My VYVGART Path representative and/or the specialty pharmacy will contact your patient to explain information on coverage and out-of-pocket costs, including co-pay card eligibility



## STEP 3

### Self-injection training



#### What you should know

##### If patient will be self-injecting:

- The specialty pharmacy will contact them to schedule shipment and training

##### Reminder to providers:

- Remind patients that when My VYVGART Path or a specialty pharmacy calls about their script, it may show up as an unknown phone number



#### Who will contact your patient

**A specialty pharmacy healthcare professional will provide in-person injection training on appropriate use, administration, storage, and disposal of the syringe:**

- Patients will receive in-person training until ready to self-inject
- Training outcomes will be reported to your office

**My VYVGART Path will provide dosing and administration education to patients enrolled in the program**



## STEP 4

### Ongoing treatment



#### What you should do

- Provide the specialty pharmacy with a refill when necessary



#### Who will contact your patient

- The specialty pharmacy will call your patient to assess adherence
- Nurse Case Managers will provide ongoing adherence and educational support to patients enrolled in My VYVGART Path
